You can claim full-time residency in two states at the same time, but it should be avoided. If a taxpayer tries to claim dual residency, then the taxpayer will be overcharged by the states. A taxpayer can be a part-time resident in one state and a full-time resident in another at the same time, according to the Internal Revenue Service website.

Can You Claim Residency in Two States at the Same Time ...
There are over 9.7 million dual eligible beneficiaries in the United States; Over half earn an income less than \$10,000, have cognitive or mental impairment, and are in " poor or fair health ". These patients account for 16% and 15% of Medicare and Medicaid beneficiaries respectively, but make up 27% and 39% of costs.

It ' s been estimated that on average the dual eligible population costs 60 percent more than non-dual eligible individuals. Dual status does not refer to your citizenship, only to your resident status for tax purposes in the United States.
